#### **NEW BUSINESS**

#### Agency Administration: Land Bank Website

Mrs. Krauss reported that she expects that the land bank website designer will have available for Commissioners' review in the next few weeks a draft of the upgraded website. She noted that the land bank is "short on satisfactory photography."

Mrs. Reimann spoke in favor of seeking photographs from the general public, as a form of community engagement. Commissioners discussed the matter of crediting; if the land bank from the outset announces it will not credit pictures it will be simpler and will avoid any legal issues, and individuals who wish for their photographs to be credited will know that the land bank website is not the forum for them.

After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote (1.) to direct staff to advertise on its facebook page and elsewhere that the institution is soliciting submissions; (2.) to stipulate that none will be credited; and (3.) to vest in Mrs. Krauss plenary authority to accept or reject submissions based on her judgment as to need and artistic quality.
