NEW BUSINESS

Agency Administration: Receipt of Donation

Staff reported a \$100 donation from Monica Finch, in memory of Dagmar Dockery. After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to accept the gift, with gratitude.

Agency Administration: Land Bank Website

Mrs. Reimann reported that she had received some feedback about the land bank's policy, adopted at its February 7, 2022 meeting, not to credit photographs on the land bank website; she wondered if the Commission would wish to re-examine it. Mrs. Goff stated that she would entertain a motion to reverse that portion of the Commission's February 7 vote; none was forthcoming and the policy will remain.

The Commission discussed Mr. Lengyel's presentation before the Martha's Vineyard Garden Club in the autumn of 2021 — which was a de facto primer on the philosophy and operations of the institution — and, in particular, whether the videotape of it should be uploaded on the land bank website. Commissioners agreed that it would be valuable for citizens to have access to such a capsulization of land bank affairs. After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to direct staff to include it, in a fitting location, on the upgraded land bank website.
