APPROVAL OF THE AGENDA

APPROVAL OF THE MINUTES OF APRIL 4, 2022

By a motion made and seconded, the Commission voted in a roll call vote five in favor, none opposed and Mr. Ewing and Mrs. Reimann abstaining to approve the minutes as written.

NEW BUSINESS

167 Main Street (Town of Edgartown)

The Commission reviewed an April 5, 2022 offer, lapsed owing to a timetable internal to the offer, to purchase this property; the buyer is listed as Ubaldo Miller and the purported price was \$2.0 million. Commissioners generally discussed prospective goals for the property in the event of a vote to declare the property surplus.

After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote (1.) to decline to consider any offers at this time; (2.) to discuss at a future meeting the best use of this property, with consideration given, in the case of a possible disposition, to concepts involving multiple parties and benefits.

Agency Administration: Fiscal Year 2023 Budget

The Commission conducted its initial review of a draft budget, prepared by staff and dated April 11, 2022, for the fiscal year beginning on July 1, 2022.

The purpose of the review was to isolate those proposed expenditures lacking consensus, for additional research and consideration; Commissioners identified such items and staff will investigate and return to a future meeting with more details and a revised budget.
