### **NEW BUSINESS**

### Agency Policy: Regionalism

The Commission conducted a second-reading of this proposed policy; the first-reading took place at its July 11, 2022 meeting.

Staff summarized the votes of the Edgartown, Oak Bluffs and Tisbury Town Advisory Boards, at their respective July 26, 2022, July 28, 2022 and July 28, 2022 meetings, to recommend that it be adopted. Commissioners reviewed an amended draft, prepared by staff, containing clarifying text.

After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to approve the policy, as amended.

### Quenomica Preserve (Town of Edgartown)

The Commission discussed an August 4, 2022 memorandum from land superintendent Harrison Kisiel regarding the possible purchase of five lockers to be used by the management staff in the new workshop to be located here. He sought bids; they following, in descending order by price: (1.) Grainger Industrial, \$3,774.25; (2.) Lowe's, \$3,266.50; and (3.) Home Depot, \$3,091.55.

After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to select the low bid.
