### APPROVAL OF THE MINUTES OF FEBRUARY 27, 2023

By a motion made and seconded, the Commission voted in a roll call vote five in favor, none opposed and Mr. Mott abstaining to approve the minutes as written.

### **NEW BUSINESS**

### Caleb's Pond Preserve (Town of Edgartown)

The Commission reviewed bids received for the installation of a driveway and trailhead here, listed in ascending order by price: (1.) \$35,000, John Keene Excavation, Inc.; and (2.) \$124,430, White-Lynch Brothers.

Discussion occurred as to (1.) the range between the bids; (2.) the invitationfor-bids that was uniformly distributed to all who requested it; and (3.) the budget for this project.

After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to award the project to John Keene Excavation. Inc., as low bidder.

## Tisbury Meadow Preserve (Town of Tisbury)

The Commission reviewed the sole proposal received for an agricultural lease here: (1.) Johanna Douglas, dated February 23, 2023. This matter had been most recently discussed at the Commission's January 23, 2023 meeting.

Mr. Kisiel reminded Commissioners that that Ms. Douglas currently leases a portion of the Wapatequa Woods Reservation for the pasturing of swine. At Tisbury Meadow she wishes to pasture cattle, a use that Mr. Kisiel stated he believes is feasible. Ms. Weaver questioned the expected water use, which Mrs. Goff speculated would not be significant. Commissioners will be mailed the proposal and it will be placed on an upcoming agenda for discussion and review.
