APPROVAL OF THE MINUTES OF MARCH 27, 2023

By a motion made and seconded, the Commission voted in a roll call vote six in favor, none opposed and Mrs. Reimann abstaining to approve the minutes as written.

NEW BUSINESS

1. Agency Land Management: Research Proposal

The Commission reviewed an April 2, 2023 letter from Allison Snow of the University of Massachusetts in which she request permission for "monitoring tick abundances along sections of public trails ... and collecting nymphs of blacklegged ticks for pathogen analyses." Ecologist Julie Russell has no objections.

After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to approve the request, provided (1.) that all aspects the project are coordinated with Ms. Russell; and (2.) that all data are ultimately supplied to her.

Trade Wind Fields Preserve (Town of Oak Bluffs)

The Commission discussed its contract with Fr. Michael Nagle, its airport services coordinator here; it calls for an annual review of services. Mr. Kisiel reported that he has assessed his performance and recommends that the contract be extended for another twelve months.

After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to accept its land superintendent's recommendation.

Wompesket Preserve (Town of West Tisbury)

The Commission reviewed a draft April 10, 2023, letter prepared by staff and special counsel Lisa Goodheart and delivered to Commissioners earlier for review, informing abutter Jefrey DuBard that the land bank will decline to enforce a deed restriction (recorded in the county courthouse at book 1629 page 130) that was recorded against the land bank's title without its knowledge. It also notes that the land bank will decline the opportunity to hold a conservation restriction over the open space, as it is satisfied with the abutting lot it owns in fee-simple.

After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to approve the letter, as written.
