#### PRESENTATION OF THE WARRANT

Warrant no. 2025-35 was made available for the Commission's inspection.

#### APPROVAL OF THE AGENDA

Hearing no proposed additions, Mr. Mott declared the agenda approved as presented.

#### APPROVAL OF THE MINUTES OF JANUARY 27, 2025

By a motion made and seconded, the Commission voted in a roll call vote five in favor, none opposed and Mrs. Reimann abstaining to approve the minutes as written.

#### TRANSFER FEE REVENUES

Revenues for the week ending January 31, 2025: \$211,255.00

#### **NEW BUSINESS**

1. Agency Land Management: Purchase of Equipment

The Commission reviewed quotes received for the purchase of a livestock shade wagon for the grazing program, arrayed in descending order by price: (1.) Serrated Shade, \$22,000 plus estimated \$3,000 shipping; (2.) Shade Haven, \$16,000 plus estimated \$3,000 shipping; and (3.) All-Cattle Shade, \$7,000 plus estimated \$2,000 shipping. \$59,000 remains in the livestock management budget.

Mr. Bell noted that the Serrated Shade product is highly portable (can be disassembled in minutes); includes a built-in suspended mineral trough to prevent waste; and is particularly wind-resistant. Shade Haven's product is reasonably portable (thirty minutes to disassemble) and fairly wind-resistant. All-Cattle's is not particularly portable or wind-resistant. He stated that Serrated Shade's product is the best of the three.

Commissioners discussed (1.) the importance of wind-resistance here; (2.) the reality that a shade wagon "is a necessity, not a luxury"; (3.) the shade wagon used with the previous herd, for goats, which didn't last; and (4.) the particular durability of the Serrated Shade product (except for the tarp itself, which can be replaced).

After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to award the purchase to Serrated Shade.

#### **EXECUTIVE SESSION**
