NEW BUSINESS

1. Agency Land Management: Purchase of Equipment

The Commission discussed bids received for the replacement of the dump body on its 2015 F550 truck. It has significant rust but the vehicle itself is still quite useful, and the body can be replaced by itself without needing to replace the existing hydraulic hoist. They are, in descending order by price: (1.) Brake and Clutch, with sandblasting and painting, \$16,395; (2.) Twin Cedars, with sandblasting and painting, \$14,650; (3.) Carey Auto, without sandblasting and painting, \$11,857; and (4.) Twin Cedars, without sandblasting and painting, \$11,650.

Mr. Kisiel recommended Twin Cedars, with sandblasting and painting so as to extend overall useful life.

After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to accept the staff recommendation.
